BYLAW No. 139, 2015

A Bylaw for the Levying of Tax Rates for Municipal, Regional Hospital, and Regional District purposes for 2015.

WHEREAS the Community Charter allows a Municipal Council to impose rates on all taxable land and improvements according to their assessed value to provide the money required for various lawful purposes:

AND WHEREAS the District of Wells is required to collect taxes and other levies imposed on taxable land and improvements according to their assessed value on behalf of the Cariboo Regional District, the Cariboo Regional Hospital District and the Cariboo Chilcotin Regional Hospital District:

NOW THEREFORE the Council of the District of Wells, in open meeting assembled, enacts as follows:

- 1. The following rates are imposed and levied on all taxable land and improvements for the year 2015:
 - (A) For the general purposes of the District of Wells on the General Taxable values of land and improvements, the rates appearing in Column "A" of Schedule "A" attached hereto and forming a part hereof;
 - (B) For the general purposes of the Cariboo Regional District on the Hospital Taxable values of land and improvements, the rates appearing in Column "B" of Schedule "A" attached hereto and forming a part hereof:
 - (C) For the rural refuse purposes of the Cariboo Regional District on the General Taxable values of land and improvements, the rates appearing in Column "C" of Schedule "A" attached hereto and forming a part hereof:
 - (D) For the general purposes of the Cariboo Regional Hospital District and the Cariboo Chilcotin Regional Hospital District on the Hospital Taxable

values of land and improvements, the rates appearing in Column "D" of Schedule "A" attached hereto and forming a part hereof.

- 2. The minimum amount of taxation upon a parcel of real property shall be One Dollar (\$1.00).
- 3. This Bylaw shall be cited for all purposes as "Tax Rates Bylaw No. 139, 2015".

READ A SECOND TIME this 21st day of April, 2015.

READ A THIRD TIME this 21st day of April, 2015.
