



**DISTRICT OF WELLS**  
**BYLAW NO. 136, 2014**

**A Bylaw to Provide for the Payment of Indemnities to the Members of the Wells District Council.**

WHEREAS, pursuant to the Community Charter, the Council of the District of Wells is empowered to provide for the payment of an annual indemnity to the Mayor and Councillors of the District of Wells, a part of which may be an allowance for expenses incidental to their duties;

NOW THEREFORE the Council of the District of Wells in open meeting assembled enacts as follows:

1. There shall be paid out of annual revenues an annual remuneration to Council members for the discharge of the duties of office as provided for in Schedule "A" attached to and forming part of this bylaw;
2. Council Indemnity Bylaw No. 115, 2011 is hereby repealed.
3. This bylaw may be cited for all purposes as "Council Indemnities Bylaw No. 136, 2014".

## Schedule "A"

### **A. REMUNERATION AND INCIDENTAL EXPENSES EFFECTIVE JANUARY 1, 2015**

- (a) That the Mayor of the Municipality shall be paid an annual indemnity of Eight Thousand Three Hundred Fifty-Nine Dollars (\$8,359.00).
- (b) That each Councillor of the Municipality shall be paid an annual indemnity of Three Thousand Four Hundred Dollars (\$3,400.00).
- (c) That a portion of the remuneration for the Mayor and Council set out above is an allowance for expenses incidental to the discharge of the duties of office, other than actual expenses incurred by the member of Council established as follows:

An allowance of Two Thousand Sixty Dollars (\$2,060.00) shall be for expenses incidental to the discharge of the duties of the Mayor and each of the Councillors.

### **B. REMUNERATION AND INCIDENTAL EXPENSES EFFECTIVE JANUARY 1, 2016**

- (a) That the Mayor of the Municipality shall be paid an annual indemnity of Eight Thousand Five Hundred Twenty-Six Dollars (\$8,526.00).
- (b) That each Councillor of the Municipality shall be paid an annual indemnity of Three Thousand Four Hundred Sixty-Eight Dollars (\$3,468.00).
- (c) That a portion of the remuneration for the Mayor and Council set out above is an allowance for expenses incidental to the discharge of the duties of office, other than actual expenses incurred by the member of Council established as follows:

An allowance of Two Thousand Sixty Dollars (\$2,060.00) shall be for expenses incidental to the discharge of the duties of the Mayor and each of the Councillors.

### **C. REMUNERATION AND INCIDENTAL EXPENSES EFFECTIVE JANUARY 1, 2017**

- (a) That the Mayor of the Municipality shall be paid an annual indemnity of Eight Thousand Six Hundred Ninety-Seven Dollars (\$8,697.00).

- (b) That each Councillor of the Municipality shall be paid an annual indemnity of Three Thousand Five Hundred Thirty-Seven Dollars (\$3,537.00).
- (c) That a portion of the remuneration for the Mayor and Council set out above is an allowance for expenses incidental to the discharge of the duties of office, other than actual expenses incurred by the member of Council established as follows:

An allowance of Two Thousand Sixty Dollars (\$2,060.00) shall be for expenses incidental to the discharge of the duties of the Mayor and each of the Councillors.

**D. REMUNERATION AND INCIDENTAL EXPENSES EFFECTIVE JANUARY 1, 2018**

- (a) That the Mayor of the Municipality shall be paid an annual indemnity of Eight Thousand Eight Hundred Seventy-One Dollars (\$8,871.00).
- (b) That each Councillor of the Municipality shall be paid an annual indemnity of Three Thousand Six Hundred Eight Dollars (\$3,608.00).
- (c) That a portion of the remuneration for the Mayor and Council set out above is an allowance for expenses incidental to the discharge of the duties of office, other than actual expenses incurred by the member of Council established as follows:

An allowance of Two Thousand Sixty Dollars (\$2,060.00) shall be for expenses incidental to the discharge of the duties of the Mayor and each of the Councillors.
